

28% of June's IPOs were from the Healthcare sector with 26 offerings raising \$4 billion\*. Total for the sector for 1H21 is 93 offerings raising \$19 billion\*.



4 of the 5 largest offerings in June were from the Technology sector with DiDi Global at the top raising \$4.435 billion\* 104

Companies publicly filed for an IPO in June bringing the YTD total to 868. 66% of the filings YTD have been SPACs followed by 14% Healthcare.



Excluding SPACs, 130+ offerings are in the pipeline with 34% from the Healthcare sector followed by 26% Technology.

**42** SPACS **filed** in June bringing the YTD total to **573** with **292** in the pipeline to price. 1H21 has already filed 77% more SPACs than full year 2020.

28 SPACS priced in June bringing YTD total to 358 raising \$100 billion\*. Overall 429 SPACs are searching for their business combination.

25 SPACS announced their business combination in June bringing the total YTD to 161 with 18 of them already completing their business combination.

**29** SPACS **completed** their business combination in June bringing total **YTD** to **64**. 26% of the business combos were from the technology sector.
