

34% of November's IPOs were from the **Technology** sector with 13 offerings raising over \$2 billion\*. The YTD count for Tech offerings is **131** raising **~\$55** billion\*. The Consumer sector led the month in IPO proceeds raising over \$2.4 billion from 10 offerings including two unicorns Sweetgreen and Allbirds.

Aside from having only 2 offerings, the industrial sector raised over half the IPO proceeds for the month. Rivian Automotive took the spotlight raising approximately \$12 billion; the largest offering since 2014. The YTD count for the sector stands at 23 offerings raising ~\$23 billion\*.

November was the slowest month in 2021 for new **filings** but one of the busiest Novembers for traditional IPOs with 32 filings. This brings the YTD count to **531**. 28% of the offerings were from the Technology sector.

The **pipeline** is robust with **142** companies who filed in 2021 in the pipeline with over 30% from the Healthcare sector. 3 companies who filed this year withdrew their registration in November bringing the YTD total for 2021 filings who withdrew to 20. There were an additional 11 withdrawals this year for companies who filed in 2020.

53 SPACs filed in November with 51% set to target "General". The YTD total is **778** with 37% of them in the pipeline. 1 SPAC withdrew its registration in November bringing the YTD total to 4.

59 SPACs priced in November bringing YTD total to **564** raising over \$136 billion\*. Over **50%** of the SPACs in November have a ≤15 month completion period. All but one offering included warrants in their units.

Over 550 SPACs are searching for their business combination with ~\$137 billion in trust. Primary sector focus is Technology.

107 Foreign Issuers

17 SPACs announced their business combination in November bringing the total YTD to 239 with 52% of them now publicly listed under the merged entity. 4 SPACs terminated their business combinations in November, including Khosla Ventures, Austerlitz Acquisition Corporation I, Hennessy Capital Investment Corp V, and Velocity Acquisition.




