# Traditional IPOs

Over **445 operating companies** went public via an IPO in 2021 raising close to \$144 billion\* with 39% of them from the **Healthcare** sector. December had the fewest offerings for the year with only 14 offerings raising \$5 billion and only 18 new filings. Over 130 offerings are in the **pipeline** with companies such as Claire's, TPG Partners, and Fogo Hospitality expected to make their public debut in 2022.

Over 25% of the IPOs in 2021 were from foreign issuers including December's largest offering from the **financial sector**, Nu Holdings. **Nu Holdings** raised approximately ~\$2.6 billion and is listed in Brazil & on the NYSE.





**613** SPACs went public in 2021, nearly **2.5 times** 2020's record count and nearly double by total raised. There was a 23% decrease in the average size of offerings in 2021 from 2020 with \$236 million\* the average for the year. Over **585** SPACs are **searching** for their business combination with over **\$142 billion**\* in trust.

Over **810 SPACs** filed for an IPO in 2021 with **264** of them in the **pipeline** to price. A total of **9** SPACs who filed in 2021 **withdrew** their offering before year end, as well as 1 offering from 2020.

# **De-SPACs**

In 2021, **265** SPACs **announced** their business combination with **150** of them making their debut in 2021. December was the third busiest month for announced combinations with a total of **28**, but also had the most terminations with **5** including **TPG Pace IV** and **EVBox, SCVX Corp** and **Bright Machine, Pathfinder Acquisition** and **ServiceMax, Northern Star Investment Corp II** and **Apex,** as well as **FAST Acquisition** and **Fertitta.** The total for 2021 was 16 **terminations**.

#### Announced Business Combinations







## **De-SPACs**

Approximately **200** SPACs **completed** their business combination in 2021 with a total enterprise value of over \$471 billion and accounted for 31% of operating company public debuts for the year. The largest SPAC merger in HISTORY, **Grab**, made its public debut after closing its merger with **Altimeter Growth** for ~\$31.26 billion.
