Congratulations to the **35** issuers in February who made their public debut via an IPO raising just over **\$3** billion* including our clients: **Arcellx, Aurora Technology Acquisition**, and **GSR II Meteora Acquisition**. SPACs and micro-cap companies led the month for activity.

Separate congratulations to the **11** companies who made their public debut via a SPAC merger in February with an enterprise value of just under **\$13 billion** including our clients: **Fast Radius, GreenLight Biosciences, Inspirato,** and **Quanergy Systems.**

Traditional IPOs

February had only **one** offering **>\$100 million** bringing the total amount raised to just shy of **\$370 million***. **Micro-cap companies** and **up-lists** led the IPO activity.

There were **17** filings in February but only 2 looking to raise over \$100 million including the medical device spin-off of **Solta Medical** from **Bausch Health**. There are **170** offerings in the pipeline with **16%** small offering up-lists and **30%** foreign issuers.






SPACs

Twenty SPACs went public in February raising close to **\$2.7 billion*** with the average offering size **\$141 million. Fifty percent** of the SPACs have a **12 month** timeframe to complete their business combination. A total of **605** SPACs are now **searching** with approximately **\$146 billion*** in trust.


Ten SPACs publicly filed for an IPO in February bringing the total number of SPACs in the **pipeline** to **210+**. February had more SPACs **withdraw** than publicly file bringing the total number of withdrawals and abandoned SPAC IPOs to **37** for 2022.





De-SPACs

February had **9** SPACs **announce** their business combination with only one having an enterprise value of over **\$1 billion.** The largest merger announced in the month was **DPCM Capital's** merger with **D-Wave** for and enterprise value of **\$1.35 billion**. There were 6 SPACs who **terminated** their agreement in February; the largest month for SPAC merger terminations in history.




Announced & Terminated Business Combinations


Average time between SPAC IPO and announced target



De-SPACs

Eleven SPACs **completed** their business combination in February with a total enterprise value of approximately **\$12.88 billion.** All the mergers included a **PIPE** to assist in funding the transaction. The largest SPAC merger for the month was **SES Holdings** merger with **Ivanhoe Capital** at an enterprise value of ~\$2.71 billion.


