Congratulations to the **20** issuers in April who made their public debut via an IPO raising just over **\$1.4** billion* including our clients, **Aimfinity Investment Corp I** and **HilleVax**. HilleVax was the only operating company to raise over \$100 million in April, as micro-cap companies continued to lead activity.

Separate congratulations to the **4** companies who made their public debut via a SPAC merger with an enterprise value of just under **\$5 billion** including our client, **Gogoro**.



Traditional IPOs

Micro-cap companies and up-lists led the IPO activity once again bringing the total raised for the month to less than **\$800 million***.

There were **25** new IPO filings in April with only **4** looking to raise over \$100 million including our client **Steinway Musical Instruments.** Over **175** offerings are in the pipeline with a **third** looking to raise **\$100 million** or more including **Specialty Building Products** and **KinderCare**.



SPACs

Ten SPACs publicly filed for an IPO in April bringing the total number of SPACs in the **pipeline** to **161**. April had a record **27** SPACs **withdraw or abandon** bringing the total number to **87** for 2022.

Seven SPACs went public in April raising close to **\$620 million*** with the average offering size **\$89 million**. Two of the **7** SPACs identified a **9 month** timeframe to complete their business combination. Three SPACs liquidated in April, bringing the total numbers of SPACs searching with approximately **\$146 billion*** in trust to **604**.



De-SPACs

April had **13** SPACs **announce** their business combination with a combined enterprise value of over **\$8.5 billion**. The largest merger announced in the month was **ICONIQ's** merger with **East Stone Acquisition** for an enterprise value of ~**\$2.5 billion**. The total number of SPACs who have announced their merger but have yet to complete is **114**. There were **4** SPACs who **terminated** their agreement in April bringing the total for the year to **19**, exceeding 2021's full year count of **17**.




Average time between SPAC IPO and announced target



De-SPACs

Four SPACs **completed** their business combination in April with a total enterprise value of approximately **\$4.96 billion.** This brings the total count for the year to **33.** The largest SPAC merger for the month was **Gogoro's** merger with **Poema Global Holdings** at an enterprise value of ~\$2.375 billion.
