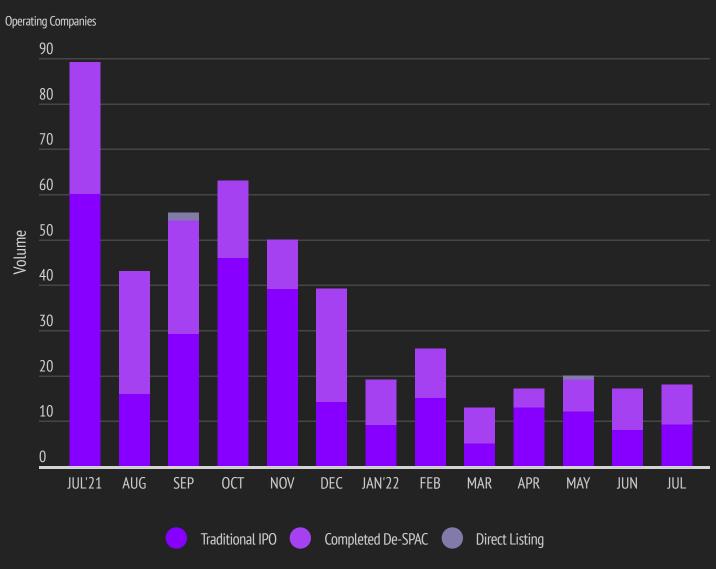

Public Debuts







The only thing that was not hot in July was the IPO market. The summer drought continued for IPO & SPAC activity with no immediate relief expected. When market volatility, geopolitical unrest, and investor confidence stabilize, a healthy pipeline of profitable companies will be ready to list."

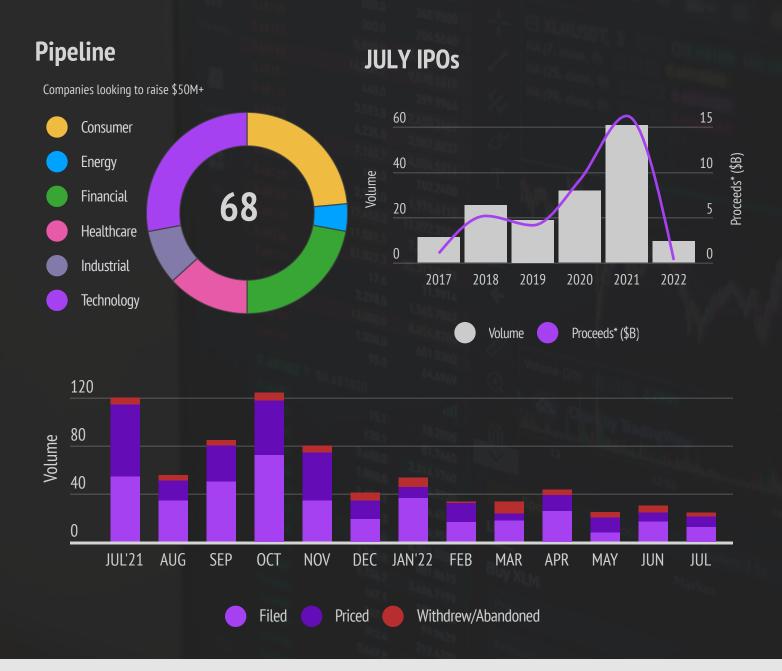

Traditional IPOs

Consistent with June, only one company **raised** over a \$100 million in July. AMTD Digital, a digital financial services provider being spun out of AMTD, raised \$125 million by offering 16 million ADSs at \$7.80.

Only one company **filed** looking to raise \$100 million or more in July. **Sedibelo Resources**, a platinum group metals miner in South Africa, is looking to raise \sim \$100 million. This brings the total number of companies in the **pipeline** looking to raise \geq \$100 million to approximately 50. Four companies withdrew their IPO registration in July bringing the total for the year to 36.





Traditional IPOs

~90% of July's offerings had an offer amount under \$25 million including 4 small up-lists. All eyes are on AMTD Digital who priced at \$7.80 and is now trading at \$1,900.

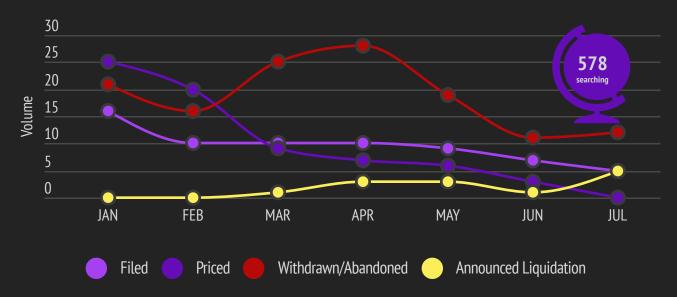

SPACs

Five SPACs publicly **filed** for an IPO in July, while twelve SPACs **withdrew** or **abandoned** bringing the total number of SPACs in the **pipeline** to **134.** No SPACs went public in July. This was the first month since February 2017.



The largest SPAC in history, Pershing Square Tontine, announced **liquidation** in July. Pershing Square Tontine terminated its agreement with Universal Music last year and was unable to complete an initial business combination within 24 months from the closing of its IPO on July 24, 2020. This brings the total number of SPACs **searching** for a target down to 578 with close to \$140 billion in trust.

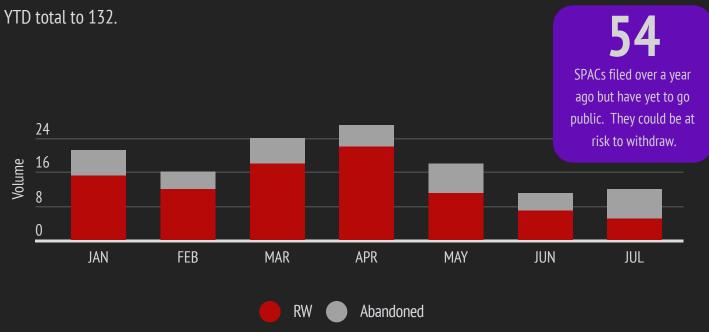

12 SPACs withdrew or were declared abandoned by the SEC in July bringing the VTD total to 132



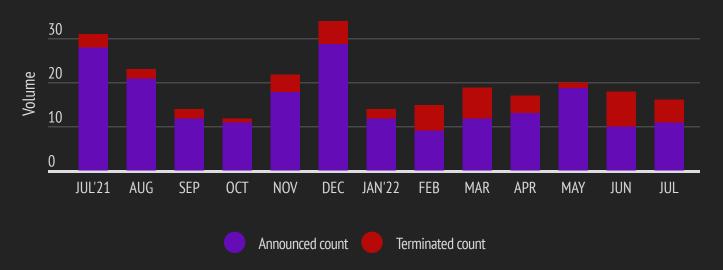

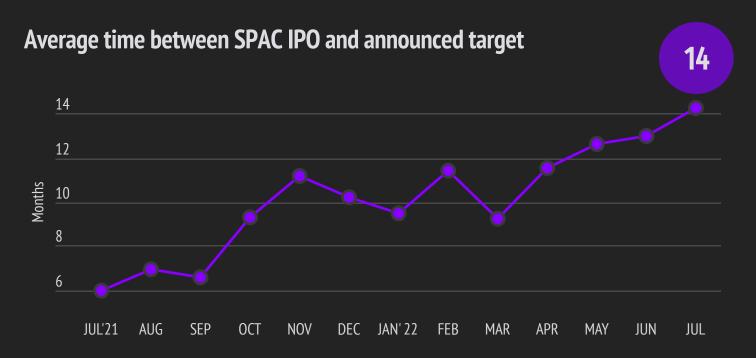
De-SPACs

July had **11** SPACs **announce** their business combination with a total enterprise value of over \$7.7 billion. This brings the total number of mergers announced for the year to **80**. The largest announced merger for the month was **Chijet Motor and Deep Medicine's** agreement to combine at an enterprise value of \$2.5 billion.

Announced & Terminated Business Combinations



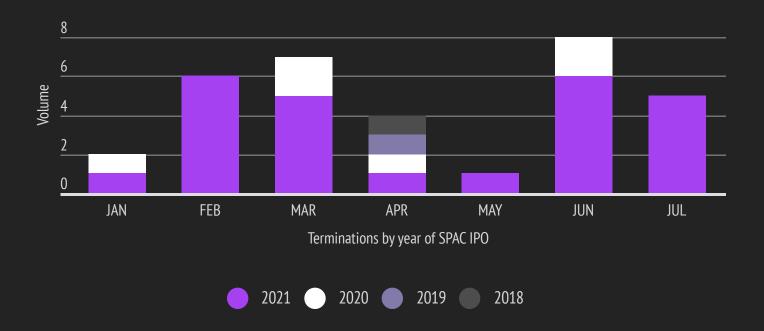
There are 115 SPACs who have announced their target but have yet to close with some facing imminent deadlines if extensions are not requested.

5 business combinations terminated their agreement in July bringing the YTD total to 33. All of the terminations in July were for SPACs who completed their IPO in 2021.



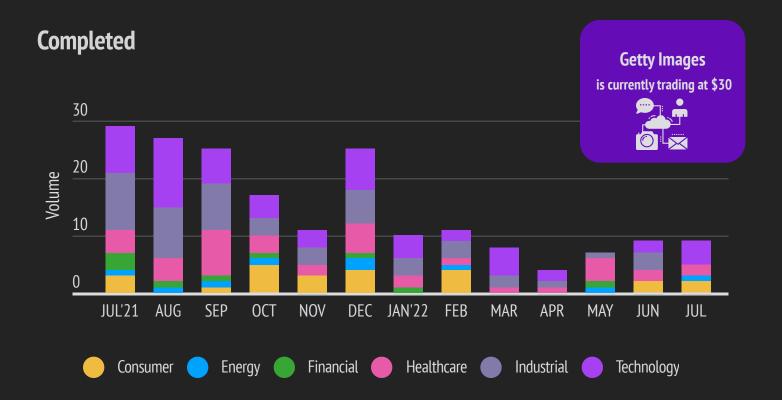

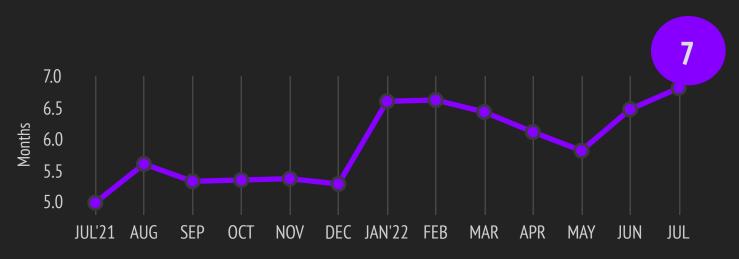


De-SPACs

Nine SPACs **completed** their business combination in July with a total enterprise value of ~ \$13.38 billion. This brings the YTD count to 58. The largest SPAC merger for July was **Getty Images** merger with **CC Neuberger Principal II** at an enterprise value of ~\$4.8 billion.

Completed De-SPACs

There was only one international issuer who made its public debut, **Gorilla Technology**, located in Taiwan. The remaining companies were located in the United States.

Five of the 9 companies are trading above \$10 per share.
