Investment companies filing deadlines, peak periods and holidays

## IMPORTANT DATES TO REMEMBER

### ANNUAL AND SEMI-ANNUAL REPORTS

**N-CSR/N-30D** and **N-CSRS/N-30D**: Mail date within 60 calendar days after the close of the period for which such report is being made; filing deadline within 10 calendar days of mail date.

**N-CEN**: Within 75 days of the fund's fiscal year-end (75 days after the calendar year-end for unit investment trusts).

### PROSPECTUS

**485APOS**: Could file anytime, but often files 60 days or more before the regularly scheduled 485BPOS.

**485BPOS**: Filing deadline 120 days from the end of the fiscal year.

**497**: Filing deadline 5 days after the effective date or from the date of offering to the public, whichever comes later.

### MONTHLY REPORTS

**N-MFP2**: Monthly within 5 business days of month end.

**NPORT-NP**: Reports for the first and second months of the fiscal quarter. File no later than 60 days after the end of that fiscal quarter (non-public).

**NPORT-P**: Report for the third month of the fiscal quarter. File no later than 60 days after the end of that fiscal quarter (public).

\*Starting with period date September 30, 2019, the exhibit required by Part F, the NPORT-EX exhibit, should be attached directly to the NPORT-P or NPORT-P/A filing for the first and third quarters of the fiscal year rather than making a separate submission.

## ADDITIONAL EDGAR FILING DATES

**Schedule 13G**: 45 calendar days after calendar year-end.

**13F**: Within 45 days after the last day of the calendar year and within 45 days after the last day of each of the first three calendar quarters of the subsequent calendar year.

**24F-2NT**: Not later than 90 days after the end of the fiscal year.

**N-PX**: 8/31 every calendar year.

### XBRL

Funds are required to file an additional post-effective amendment (485b) with the XBRL as an exhibit within 15 business days of the effectiveness date of the prospectus to which it relates. If the fund company has changes to the risk/return summary, and files, pursuant to rule 497(c) or (e), they may file an XBRL exhibit with the 497 filing or they may file another 497 for the exhibit only, 15 days after such filing.

### XBRL

Starting September 17, 2020, large fund groups must file Inline XBRL (iXBRL). The 15-business-day filing deadline has been eliminated. The Interactive Data Files must be filed concurrently with the filing or in a subsequent amendment that is filed on or before the date the post-effective amendment becomes effective.

### SEC HOURS OF OPERATION

The hours of operation for transmitting submissions to the SEC's EDGAR system are 6:00 a.m. to 10:00 p.m. Eastern Time, weekdays, excluding U.S. federal holidays. Filings submitted after 5:30 p.m. Eastern Time (with the exception of Section 16 filings, Correspondence and filings pursuant to Rule 462(b)) will receive the next business day's filing date. If a filing date falls on a weekend or federal holiday, the due date will fall on the next business day, pursuant to Securities Exchange Act of 1934 Rule 0-3(a) and the Investment Company Act of 1940 Rule 0-2(a).

**DEADLINE DATE CALCULATIONS**: If the calculated deadline fell on a weekend or holiday, the filing deadline is moved to the next business day after the deadline.
