#### WHAT IS A PRIIPS KID?

A PRIIPs KID (Key Information Document) is a three-page pre-contractual document that provides investors with key information on the investment products they may be interested in

It includes information regarding the type of fund, the fund objective and the intended investor type that can invest in the fund. It also provides information on the risk and return, the costs associated with investing into the fund and information regarding the fund's manufacturer.

Implementation, production, distribution and general maintenance of the KID can create significant challenges for asset managers. ArcRegulatory overcomes these issues by leveraging DFIN's innovative global regulatory reporting platform.

ArcRegulatory covers all aspects of PRIIPs KID production through a single platform, which incorporates data ingestion, data integration, calculation, translation, production, monitoring/exception reporting and distribution.

ArcRegulatory calculates and produces **20,000** EPTs per month.

**Data Transparency and Intuitive Process:** All associated PRIIPs KID data is available for review through dashboards and can be exported at any stage of the production process. End users can monitor data changes directly via the dashboards, providing transparency over the process.

**Risk and Performance Calculations:** ArcRegulatory operates from a standard data model that checks inbound data consistency as well as performing tolerance checks on all calculations.

**Reduction in Yield Calculations:** ArcRegulatory automates all reduction in yield calculations.

**Transaction Cost Calculations:** ArcRegulatory calculates transaction costs (ex ante and ex post) using full PRIIPs, new PRIIPs or a hybrid of both. In addition, the platform has the ability to source arrival prices used in these calculations.

#### **Content Review**

The introduction of PRIIPs KIDs allows for an opportunity for all asset managers to review and standardise their regulatory documentation. #### **Data Management and Calculations**

The introduction of the PRIIPs KID requires that you produce the following calculations:

- 1. SRI: Synthetic Risk Indicator
- 2. Performance Scenarios: Stress, Unfavourable,
  Moderate and Favourable Scenarios
- 3. RIY: Reduction in Yield Calculations
- **4.** Costs: General Costs and Transaction
  Cost Calculations

The ArcRegulatory data model supports all of the aforementioned calculations as well as supporting the production of EPTs, EMTs, DCPTs and ICTs. This flexible data model allows you to standardise your inbound data feeds and automatically validate them against over 1,000 data field checks. This level of automation greatly optimises the operational processes associated with PRIIPs KID production.
