**Alternate Text** – Text applied to graphics that lets a screen reader describe or read out loud the graphic content

**JAWS** – Job Access With Speech, one of the world's most popular screen readers

**NVDA** – Non-Visual Desktop Access is a free screen reader that enables vision-impaired people to access computers running Windows

**PDF/UA** – Portable Document Format, Universally Accessible is an ISO standard for accessible PDF technology

**WCAG** – Web Content Accessibility Guidelines is a universal standard that defines how to make web content more accessible to people with disabilities
