CHALLENGE

Reviewing 1200–1400 documents in one week

Representing the seller in a >\$1 billion M&A transaction, the firm had one week to perform sell-side diligence at the client's request. Since they needed to review 1200-1400 documents and populate related disclosure schedules, pure manual review was not an option within the time constraint.

Having piloted eBrevia on a smaller buy-side due diligence project, the team looked to the software as a supplement to make them more effective, efficient and accurate – in record time.
