
**Operating Companies** 

Congratulations to the 36 operating companies in Q3 who made their public debut via an IPO raising ~\$8 billion and the 30 companies who made their public debut via a SPAC merger. Special congratulations to our clients: Abacus Life, Allurion Technologies, Arm Holdings, Bitcoin Depot, Calidi Biotherapeutics, Carmell Therapeutics, Cheche Group, Complete Solaria, Earlyworks, Electriq Power, Instacart, Mobile Infrastructure, Neumora Therapeutics, Nuvini, Pixie Dust Technologies, RayzeBio, Roadzen, Turnstone Biologics, and VinFast Auto.





Seven of the 36 IPOs in Q3 were \$100M+ offerings. This is a slight decrease by volume for offerings of this size but an increase by proceeds from 2Q23. The remaining 29 offerings in the quarter were micro/nano-caps raising a combined total of approximately \$438 million.



Nine companies withdrew their IPO registration in Q3 including Aleph Group, HomeSmart Holdings, KinderCare, REV Renewables, and Sedibelo Resources, who had \$100M+ placeholders.

Only 22 companies who publicly filed their registration statement with a \$100 million+ placeholder remain in the IPO pipeline. Confidential filings have increased over the past few months and should soon bring some much-needed volume to the public IPO pipeline.






Four out of the seven companies who raised \$100M+ in their IPO in Q3 are trading above their IPO price. Arm Holdings was the largest offering in the quarter raising \$4.9 billion; it's trading slightly above its IPO price @ \$51.96.









Biotech companies made their public debut via an IPO in Q3 raising ~\$1 billion. RayzeBio and Apogee Therapeutics are trading above their debut share price.




# **SPAC Activity**

Seven SPACs publicly filed for an IPO in Q3 while 8 SPACs withdrew or were declared abandoned. This brings the total number of SPACs in the pipeline to 37. A total of 5 SPACs made their public debut raising a combined total of approximately \$765 million. This brings the average offering size for 2023 to approximately \$140 million. Eleven SPACs who filed in 2021 have yet to go public and are at risk to be declared abandoned.



33 SPACs who raised a combined total of ~\$8 billion in their IPOs liquidated in Q3. The majority were SPACs who made their public debut in 2021. This was the lightest quarter for liquidations this year. The number of SPAC searching for a target is down to 168.





Q3 had 34 SPACs announce their business combination including Churchill Capital Corp VII who agreed to combine with UK-based long-term corporate acquirer, CorpAcq. The enterprise value for the deal is \$1.5 billion. Churchill Capital Corp VII went public in 2021 raising \$1.2 billion.





Thirty SPACs completed their business combination in Q3 with a total enterprise value of approximately ~\$46 billion. This was the most active quarter by volume since 4Q21. More than half of the total enterprise value came from the merger of Black Spade Acquisition and VinFast Auto for an enterprise value of \$27 billion. VinFast Auto is currently trading at \$9.04.
